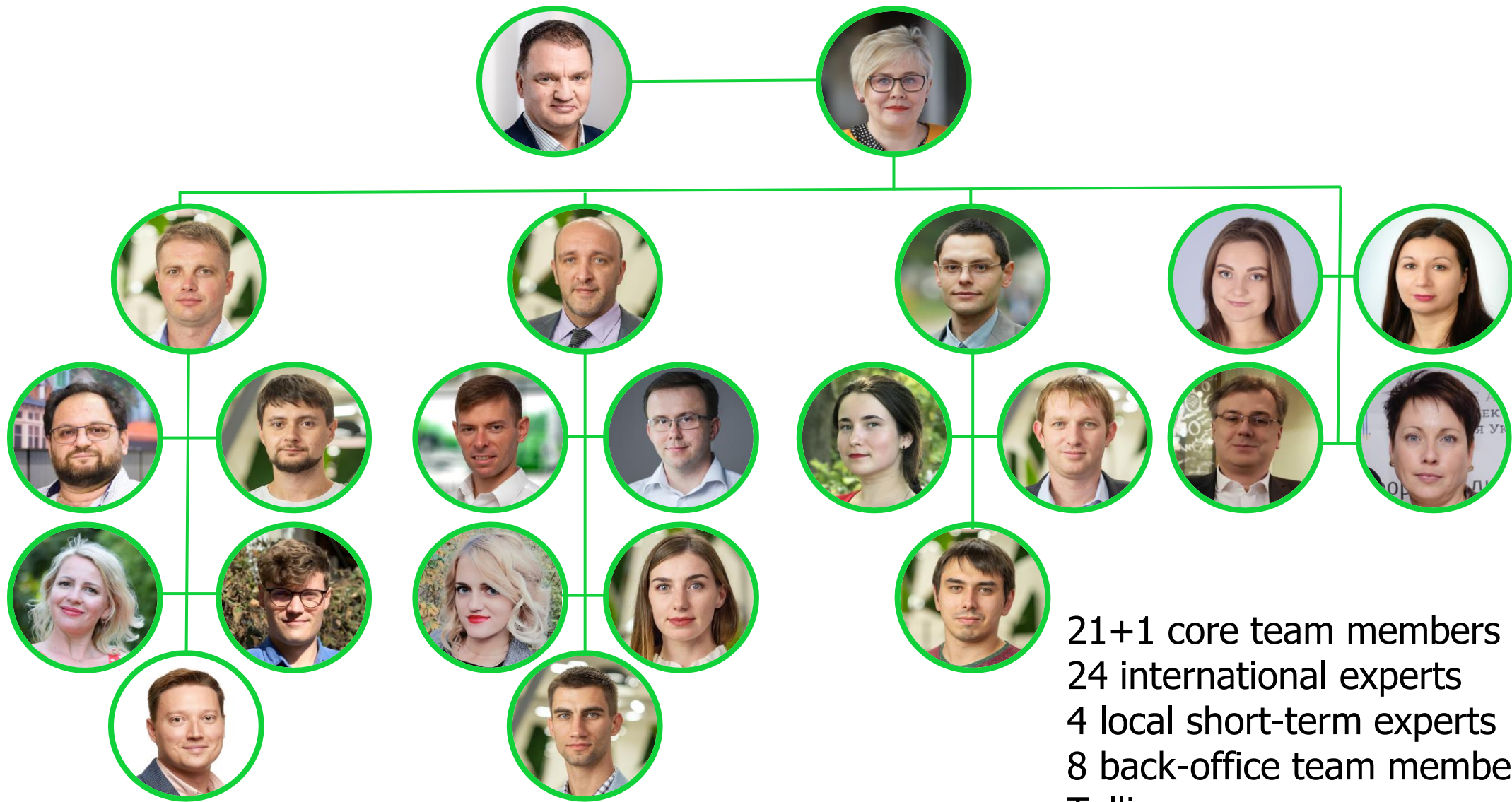
EU4DigitalUA

- Part of EU-funded “EU Support to E-Governance and Digital Economy in Ukraine Programme” launched in 2021 with total budget € 25 million
- Implemented by Estonian e-Governance Academy (eGA) and Spanish International and Ibero-American Foundation for Administration and Public Policies (FIIAPP)
- Part of the digital transformation reform: Aimed to improve the efficiency and security of public service delivery and their access to citizens and businesses in Ukraine
- Beneficiary: Ministry of Digital Transformation of Ukraine
 - + 16 recipients
- 01.10.2021 – 31.03.2024
- Budget: € 10,002,600.00
